Privacy Policy

Hafizlist privacy policy

1. Account information

If you create an account, you must provide us with some personal data so that we can provide our services to you. On Hafizlist this includes first name, last name, username (concatenation of first and last name), a password, and an email address and/or phone number. Your first and last name and username are always public as well as your title (Hafiz or Murid). You can only have one account on Hafizlist that represents your identity. If we found that one person is using two or more account we can suspend more than one account.

2. Public information

Most activity on Hafizlist is public such as profile information, your time zone and language, when you created your account, your posts, dates, times, and application and version of Hafizlist you post from. You are responsible for your posts and other information you provide through our services and you should think twice about what you make public.

3. Contact information and address books

We use your contact information, such as your email address or phone number, to authenticate your account and keep it – and our services – secure, and prevent spamming.
